In compliance of the judgement and order passed by this Court on 17.2.2022, a report has been submitted to this Court through the letter dated 30.3.2022 duly signed by Hon'ble Mr. Justice Kamleshwar Nath(Retd.). The managing body of 11 trustees as nominated by three member committee appointed by this Court is placed on record by the Senior Registrar on 30.03.2022. The letter dated 30.03.2022 to which the compliance report is annexed is marked as IA No. 33 of 2022. The said application along-with the report shall form part of record.

The names of the trustees against each office in the compliance report are named as under :-

The management body of 11 trustees as above nominated by the three member committee in compliance of the judgement/order dated 17.2.2022 is confirmed and shall form part of the judgement and order dated 17.2.2022. The report submitted to this Court on 30.3.2022 by the three member committee being part of the record shall be preserved.

The three member committee has also proposed substitution of Rule 7 of the scheme of management as under :-

*"7. Tenure of Trustees: The tenure of the Trustees shall be 5 years renewable for not more than one term of 5 years. A trustee may resign in writing signed and addressed to President; the resignation shall become operative from the date on which it is accepted by the Trust Management Committee."*

The proposal submitted by the three member committee for deletion of the previously drafted Rule 7 and substitution of the same as above is accepted and the Rule reproduced above shall be substituted and read accordingly in the scheme of management of Aliganj Mahaveer ji Trust flagged as "Annexure F".

The Senior Registrar of this Court is directed to forward a true copy of the amended scheme flagged as "annexure F" as well as the list of 11 trustees named herein-above for publication on the notice board of Aliganj Mahabirji Trust by the District Judge, Lucknow as per the mandate of judgment dated 17.02.2022. The report of publication on the notice board be accordingly submitted to this Court on or before 20.10.2022 so that further execution proceedings are drawn with due participation of the new management body of trustees.

For execution of the judgement dated 17.2.2022 and to oversee the smooth transfer of the management of the trust to the newly constituted body, the Court hereby constitutes a three member committee comprising of Police Commissioner, Lucknow, District Magistrate, Lucknow and Chief Judicial Magistrate, Lucknow to aid and assist the District Judge, Lucknow for publication of the ' scheme of management along-with the management body of trustees without any further delay.

Let a copy of this order be communicated to the Chief Judicial Magistrate, Lucknow, District Magistrate, Lucknow, Commissioner of Police, Lucknow as well as the three member committee for information and doing the needful.
